STATE of ARKANSAS ARTICLES of INCORPORATION A NON-STOCK CORPORATION

"[Operating Business Name]"

THE UNDERSIGNED natural person being the age of eighteen (18) was or more, acting as incorporator of a corporation under provisions of Act 1147 of 1993 known as the Arkansas Non-Profit Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I CORPORATE NAME

1.1 The name of the corporation is "[Operating Bush, ss. [ame]"

ARTICLE II

2.1 The period of duration of this corporation is perpetual.

AR VELE III PERPOSES

- 3.1 The corporation is organized exclusively for charitable and educational purposes, and not for probability ding:
 - (a) To act and operate exclusively as a nonprofit corporation pursuant to the laws of the State of Arkansas and to act and operate as a charitable organization in less ning the burdens of government, providing relief of the poor, the hungry, the homeless, and distressed by educational training program, self-help program, providing financial support and providing food and clothing to the aforesaid.
 - (b) To engage in any and all activities and pursuits, and to support or assist such other organizations, as may be reasonably related to the foregoing and following purposes.
 - (c) To engage in any and all other lawful purposes, activities and pursuits, which are substantially similar to the foregoing and which are or may hereafter be authorized by Section 501(c)(3) of the Internal Revenue Code and are
